- If you have a Concealed Weapons Permit, you are NOT permitted to bring a weapon on the campus OR permitted to have weapon in your vehicle.
- Firearms of any type (unless in official capacity)
- Taser/Stun Guns
- Batons
- Mace/Pepper Spray
- Pocket Knives with blades greater than 2.5 inches in length
- Fixed-blade Knives any length
- Brass Knuckles or similar devices
- Fireworks

- Illegal Drugs
- Legal Narcotic Medications (without a prescription)
